- * After the acceptance of the Application form, Fair sends the invoice calculated by the Application to the exhibitor.
- * The payment is the condition of participation. All exhibitors are obliged to show the proof of payment to the Fairs authorized staff before the exhibition.
- * The amount for additional services and eventual differences between requested and assigned space are paid by the additional invoice immediately after receiving it.

- * Opening hours of the exhibition defines the Management of Adriatic Fair. Working hours is from 6 p.m. - 11 p.m. The exhibitor cannot abandon the exhibition space until the last working day of the Fair ends.
- * The exhibitor is not allowed to give another exhibitor a part or entire exhibition space without a permission of the Adriatic Fair.
